





Figure 3. Capacitance







Figure 4. On-Resistance Variation with Temperature




Tj, Junction Temperature(°C)
 Figure5.Gate Threshold Variation With Temperature




Tj, Junction Temperature (°C)
 Figure6.Breakdown Voltage Variation With Temperature




Ids, Drain-Source Current (A)

 Figure8.Body Diode Forward Voltage Variation with Source Current



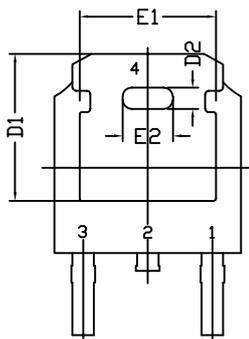
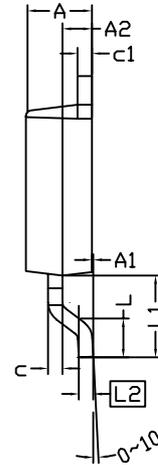

Qg, Total Gate Charge (nC)
 Figure9. Gate Charge



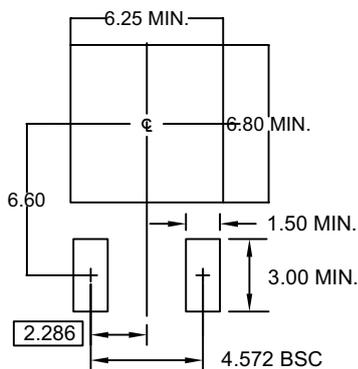
