



**Figure 1: Power Dissipation** 





Figure 3: Safe Operation Area



**Figure 5: Output Characteristics** 





Figure 2: Drain Current



**Figure 4: Thermal Transient Impedance** 






Figure 6: Drain-Source On Resistance

**Figure 9: Capacitance Characteristics** 






Figure 8: Source-Drain Diode Forward




**Figure 10: Gate Charge Characteristics** 


